Domestic Use Tariffs

Codes 01, 02 and 08

Tariffs for Domestic Use

Tariffs for **Domestic Use** are applicable where the electricity is solely used for domestic purposes to private dwellings. They are not applicable for exercising any profession or carrying out any commercial or industrial operations or business or for any other purposes related to these professions, commercial/industrial operations and business.

For the purpose of these tariffs, in case a question arises, whether the electricity supply is intended for any of the above mentioned purposes, EAC shall decide on the matter and its decision shall be final.

These tariffs are not applicable to electricity supplies for stand-by purposes.

Single Rate Domestic Use Tariff (Code 01)

The bi-monthly charges, at the basic price of €300/M.T. of fuel cost, for the supply of electricity based on this tariff, are given below:

The Energy Charge per kWh is based on the energy price of the Wholesale Tariff T-W and the basic price of RES purchases for 2024.

Fuel Adjustment Clause

In each bi-monthly period, the price of unit (kWh) charged shall be increased or decreased by the value of the Coefficient of Fuel Adjustment currently in force, for every 1 cent increase or decrease in the basic price of €300 per metric tonne of fuel cost, which cost shall be defined by EAC for the bi-monthly period, based on the purchase price of fuel.

Two Rate Domestic Use Tariff (Code 02)

The bi-monthly charges, at the basic price of €300/M.T. of fuel cost, for the supply of electricity based on this tariff, are given below:

Fuel Adjustment Clause

In each bi-monthly period, the price of unit (kWh) charged shall be increased or decreased by the value of the Coefficient of Fuel Adjustment currently in force, for every 1 cent increase or decrease in the basic price of €300 per metric tonne of fuel cost, which cost shall be defined by EAC for the bi-monthly period, based on the purchase price of fuel.

Domestic Use Special Tariff for Specific Categories of Vulnerable Customers (Code 08)

The domestic use special tariff for specific categories of vulnerable customers with code 08 is applicable to customers who either themselves or other person with whom they live permanently, are included to each of the following categories of customers provided they are Cypriot citizens or citizens of any other Member Country of the European Union or the European Economic Area or citizens with equal rights to the above, who are legally residing in the areas controlled by the Republic of Cyprus:

1. Public Assistance recipients from the Social Welfare Services of the Deputy Ministry of Social Welfare
2. Beneficiaries of Guaranteed Minimum Income provided by the Welfare Benefits Administration Service of the Deputy Ministry of Social Welfare
3. Large families that receive Child Benefit from the Welfare Benefits Administration Service of the Deputy Ministry of Social Welfare for three or more dependent children
4. Beneficiaries of Allowance to Pensioners with Low Income provided by the Welfare Benefits Administration Service of the Deputy Ministry of Social Welfare
5. Beneficiaries of Single Parent Family Benefit which is granted in addition to the Child Benefit from the Welfare Benefits Administration Service of the Deputy Ministry of Social Welfare
6. Beneficiaries of Severe Motor Disability Allowance from the Department for Social Inclusion of Persons with Disabilities of the Deputy Ministry of Social Welfare
7. Beneficiaries of Care Allowance for Paraplegic Persons from the Department for Social Inclusion of Persons with Disabilities of the Deputy Ministry of Social Welfare
8. Beneficiaries of Care Allowance for Quadriplegic Persons from the Department for Social Inclusion of Persons with Disabilities of the Deputy Ministry of Social Welfare
9. Beneficiaries of Mobility Allowance for hemodialysis patients from the Department for Social Inclusion of Persons with Disabilities of the Deputy Ministry of Social Welfare
10. Beneficiaries of Special Allowance for Blind Persons from the Department for Social Inclusion of Persons with Disabilities of the Deputy Ministry of Social Welfare
11. Beneficiaries of a Special Monthly Pension from the Patient Relief Fund, whose details will be provided on a continuous basis by the Committee for the Relief of Patients, which operates based on the provisions of the Relief of Patients Law No.114/1988, as amended from time to time or replaced
12. Patients undergoing peritoneal dialysis whose details will be provided by the Health Insurance Organization
13. People suffering from multiple sclerosis (ms) whose details will be provided by the Health Insurance Organization
14. People after heart transplant surgery whose details will be provided by the Health Insurance Organization
15. People with active Acromegaly whose details will be provided by the Health Insurance Organization
16. Patients with Cushing syndrome whose details will be provided by the Health Insurance Organization
17. People with Pheochromocytoma whose details will be provided by the Health Insurance Organization
18. People with autoimmune diabetic neuropathy whose details will be provided by the Health Insurance Organization
19. Patients with permanent tracheostomy whose details will be provided by the Health Insurance Organization
20. Patients with primary or metastatic Central Nervous System tumor (brain or spinal cord) whose details will be provided by the Health Insurance Organization.

The bi-monthly charges, at the basic price of €300/M.T. of fuel cost, for the supply of electricity based on this tariff, are given below:

Fuel Adjustment Clause

In each bi-monthly period, the price of unit (kWh) charged shall be increased or decreased by the value of the Coefficient of Fuel Adjustment currently in force, for every 1 cent increase or decrease in the basic price of €300 per metric tonne of fuel cost, which cost shall be defined by EAC for the bi-monthly period, based on the purchase price of fuel.

- ❖ The contents of the referred Definitions and Notes are applicable and constitute integral part of the tariff.

DEFINITIONS

“Bi-monthly Period”, where the meter readings are taken bi-monthly, means the period from the commencement of the supply to the first routine meter reading or the period from one such reading to the next or the period from one such reading to the termination of the supply on any particular tariff, as the case may be. Where meter readings cannot be taken during the bi-monthly period, the bi-monthly consumption shall be estimated.

“Standard Periods” are the periods between 09:00 hrs and 23:00 hrs.

“Economy Periods” are the periods between 23:00 hrs and 09:00 hrs.

“Cost of fuel per metric tonne” means the average cost of fuel during the period coinciding with or preceding the period of consumption, as defined by EAC.

“Unit” means one kilowatt-hour (kWh).

“Low Voltage” means supply of electricity metered at 500 volt or less.

NOTES

- (1) The Coefficient of Fuel Adjustment is revised on a six-month period basis, according to the Cyprus Energy Regulatory Authority’s Decisions. Its current price is published on EAC’s website.
- (2) In the case of premises with more than one occupier/customer, where a separate point of supply is provided for each occupier/customer, EAC shall charge for each point of supply separately.
- (3) When more than one point of supply is provided to a customer, EAC has the authority and right to apply the appropriate tariff to each point of supply.
- (4) Where to a point of supply, more than one tariff might be applicable, the customers are entitled to change their existing tariff to another alternative tariff after a minimum of six bi-monthly periods have elapsed from the date when their premises are charged with the current tariff. A written notice (application) to that effect is required to be given to EAC.

EAC has the right to decide which of the tariffs are applicable to any point of supply and any type of use.

- (5) Existing customers terminating their supply are not charged for Meter Data Management Cost.
